ORDER

WHEREAS, recognition was granted by the Northern Regional Committee to Saraswati College of Education Village-Sardar Shahr, Street/Road-Sardar Shahr, Tehsil/Taluka-Sardar Shahr, Town/City-Sardar Shahr, District-Churu, State-Rajasthan, Pincode-331403 vide order no. F.No.NRC/NCTE/NRCAPP-2016-15091/Recognition/269th meeting (part-9)/2017 dt. 02.05.2017 for B.A. B.Ed/B.Sc. B.Ed course of four years duration with an annual intake of one unit of 50 students.

AND WHEREAS, the institution submitted a representation, received in the NRC office on 07.02.2018 requesting for change of name of the institution from Saraswati College of Education to Saraswati Teachers Training College.

AND WHEREAS, the matter was placed before the NRC in its 280th meeting held from 06th to 07th February, 2018 and the Committee decided as under: -

- The request of the institution has been considered in the light of NCTE (HQ) letter No. F.No.49-3/2016/NCTE/N&S/47143 dated 08.12.2016 which *inter-alia* provides that "With respect to change of name of the institution, this may be permitted if the land is not transferred to the existing institution proposed to be changed. If the land is already transferred from Society to the institution or if the land is the name of the institution any change in the name of institution shall essentially require change in the ownership of the land. In this case processing fees may be charged for inspection process."
- In this case, since the land is in the name of the sponsoring Society, hence, the request dated 07.02.2018 submitted by the institution for change of name of the institution from Saraswati College of Education to Saraswati Teachers Training College is accepted and permitted by NRC.

Orders be issued accordingly.

NOW, THEREFORE, the Northern Regional Committee hereby grants permission to the institution for change of name from Saraswati College of Education to Saraswati Teachers Training College.
